The new film *Bought: The Truth Behind Vaccines, Big Pharma and Your Food* can be viewed for \$4.95 through Mercola.com as a fundraiser for NVIC until Nov. 21, 2014. The film focuses on Big Pharma and Big Agriculture cover-ups and profit-making in the drug, vaccine and GMO food industries. Producer Jeff Hays said, “From opiates, to statins, to a blizzard of psychotropic medications that do far more harm than good, the film covers how our entire health care system, from education to practice has been ‘Bought.’”
